Privacy Policy

The Information We Gather

Hammerweb Holdings does not collect any personal information from a visitor to our web site unless that visitor explicitly and intentionally provides it. Other products and services may require additional or supplemental information from you in order to purchase.

In addition, information we automatically collect via industry standard web log files includes the URL from which you visited, the page you are visiting, your computer browser information and your IP address. We may also track the effectiveness of various features of our web site through

the use of data collection devices known as "cookies." Cookies contain specific pieces of information on your computer hard drive, and can be set to store information during a visit or for a longer period of time. Our cookies are not tied to personally identifiable information.

How We Use the Information We Gather

The Information on the Systems We Create

Hammerweb Holdings develops and provides programs and applications to Hammerweb Holdings' clients. These systems are based on clients' requests and requirements. We do not manage the information collected in any system we produce for clients. While certain personal information collected by our clients might reside, temporarily or permanently, on software or hardware that Hammerweb Holdings owns, licenses or can otherwise access, Hammerweb Holdings' clients remain solely responsible for managing the information contained on the systems. Hammerweb Holdings does not make any assumptions as to what clients will do with the information they collect. If Hammerweb Holdings is ever granted access to data within a client's system, we do not manipulate, edit or otherwise use, distribute or resell the data or personal information.

Information Security

The systems produced by Hammerweb Holdings are verified as "secure and reliable" by Starfield Technologies, Inc. and/or Comodo CA Ltd. Information is secured both during transmission and online storage. If a particular system developed by Hammerweb Holdings involves integrated payment processing (Credit card, Pay Pal, e-Checks, etc.), the account information is not stored in the database we developed. Rather, the account information is stored by the credit card processor, Pay Pal or banking institution. Please contact the client or company/association with any and all questions related to payment processing or payment refunds. If a particular system developed by Hammerweb Holdings includes the collection of Social Security Numbers, only the last four digits of the Social Security Number are stored in the database, unless otherwise requested or instructed by the client or association.
